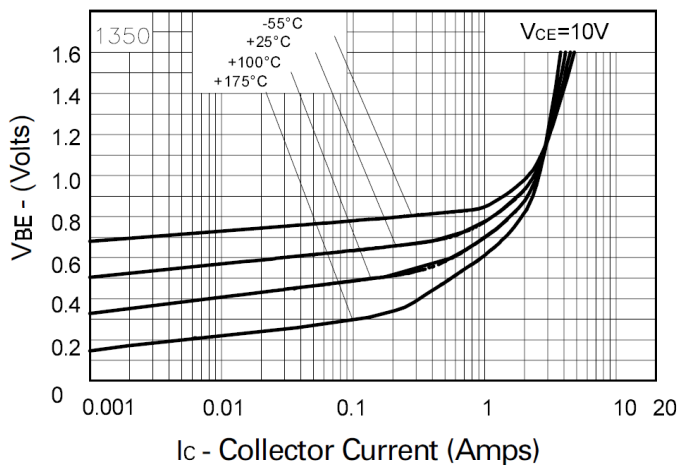
**VCE(sat) v IC**



**hFE v IC**



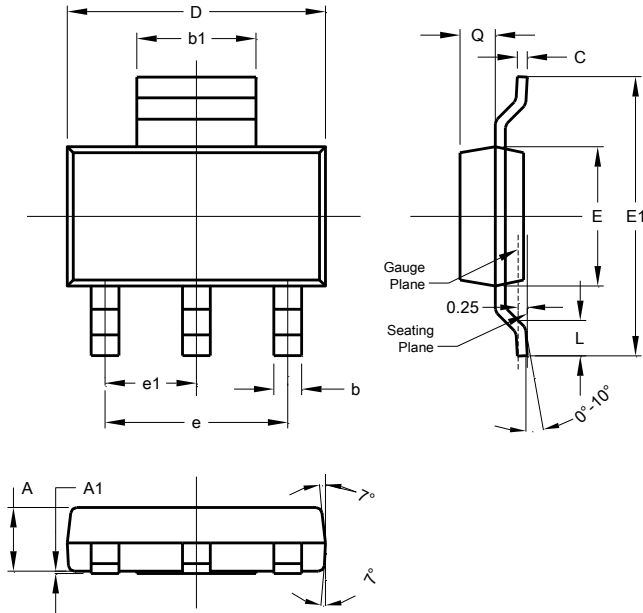

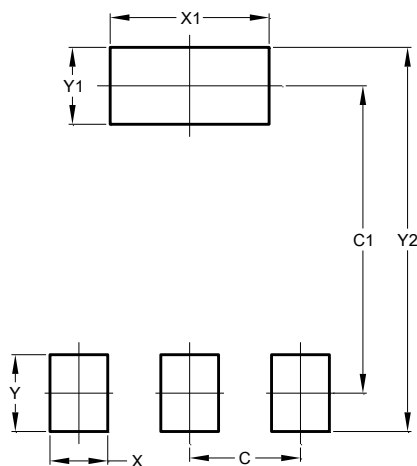
